You will liaise between L&D lead and cross-functional internal teams to ensure the timely and successful delivery of our FITT video offering.

### **Responsibilities**

- Develop initial strategy for FITT members within the existing FITT parameters
- Suggest tools for execution ie film, edit, publish, which will deliver against KPI's including fiscal restraints (as FITT is a NFP organisation)
- Ability to be across other diversity offerings and create a specific and ownable destination niche for this segment
- Present a 12 month plan of deliverables (topics, speakers etc) which dovetail and support other FITT offerings such as IWD, networking and roundtable outputs
- Available for execution and delivery of above
